Your applications that are submitted to us shall be replied within thirty days at the latest following the delivery according to the nature of the request as per the 2nd paragraph of article 13 of the Law. Our replies have been sent in writing or electronically in pursuant to article 13 of the "Law".
- 6. If the requested transaction requires an additional cost, please be advised that you will be asked to pay the fee in the fee tariff specified by the Board. In case of a written reply to your application, the first 10 (ten) pages will not be charged, and the transaction fee at the tariff determined by the Board will be charged for each page above 10 (ten) pages. If the answer to your application is given in a recording medium such as CD or Flash Memory, the fee will be reflected to you by the cost of the recording medium.
- 7. GLOBAL reserves the right to change the application procedures pursuant to Board's decisions or regulations in the future.
