

## OUR COOKIE POLICY

At GLOBAL YATIRIM HOLDİNG ANONİM ŞİRKETİ (“GLOBAL” or “Company”), we show high precision for the processing and protection of personal data belonging to our visitors <https://www.globalyatirim.com.tr/tr/> (“Our Websites”) in accordance with the Law No. 6698 on Protection of Personal Data (“Law No. 6698”) and secondary regulations.

As GLOBAL, we would like to inform you about the cookies used by our websites and your personal data processed through this “Our Cookie Policy” under the inform obligation arising from the Protection of Personal Data legislation.

### What kind of cookies do we use?

Cookies are small text files created by a website on your device that contain data in name-value format. Therefore, the cookies that we use to visit our Websites on your device, storing information about your visits to the site and this information makes it possible remember your preferences next time you visit the website again.

Cookies created by our Websites and can only be read by our Websites are **first-party cookies**.

The content offered on our Websites is also provided through other domains besides the domain name at the access address. In this case, each domain name creates unique **third-party cookies**.

The types of cookies we use on our Website and our purposes for using these cookies are as follows:

No.	Types of internet cookies	Purpose of Use
1.	<b>Session Cookies</b>	Session cookies are cookies that valid during your use of the websites and they remain valid until you close your internet browser.
2.	<b>Permanent/ Persistent Cookies</b>	These cookies are cookies that are stored in your internet browser and remain valid until they are deleted by you or until the expiration date.
3.	<b>Mandatory Cookies</b>	Cookies are mandatory to use for the websites to work properly, to benefit from their features and services.
4.	<b>Functional and Analytical Cookies</b>	Cookies that are used for purposes such as remembering your behavior and preferences during your visit to our Sites, the effective use of our Sites, and optimizing our Sites to respond to your wishes, and containing data about how you use the site. According to its qualifications, such cookies may contain your personal data. Through these cookies, for example, your language preference for viewing our Sites is processed.

We aim to provide you a more efficient and functional internet experience with the third-party cookies we use on our sites. Privacy Agreement in accordance with PPD legislation has been concluded between these third-party service providers and **GLOBAL** and the security of your personal data is guaranteed.

### **Storing and Accessing Cookies**

The cookies created by our Websites are stored on your computer by the internet browser which you use to access our Websites. The information contained in these cookies can only be accessed remotely by our Websites, which are provided under the cookie domain (<https://www.globalyatirim.com.tr/tr/>) and if you use the same internet browser.

### **To Accept Cookies Is In Your Hands/ Accepting Cookies Your choice**

Your internet browsers automatically accept cookies used on the Websites you visit. The use of cookies is not mandatory to use our Websites, but if you have set your browser to block all cookies, the quality of your user experience may decrease and may prevent you from accessing our websites or using the various functions of our websites.

You can configure your internet browser to block cookies for all or certain websites, alert when cookies are created, block third-party cookies, or count all cookies like a session cookie.

On the other hand, you can delete cookies that are stored on your device through your internet browser or see and follow the list and values of these cookies. You can get detailed information about cookie management by clicking on the internet browsers listed below.

### **Security of Your Personal Data**

Cookies are not used for purposes other than those stated in this "Our Cookie Policy" and all related transactions are carried out in accordance with the Law No.6698. Your personal data obtained through cookies are processed, stored and secured by **GLOBAL** in accordance.

### **Rights of the Personal Data Subject**

Within the scope of Article 11 of the Law No. 6698, by applying to **GLOBAL** for your personal data;

- to find out whether their personal data are processed or not,
- to request information about their processed personal data,
- to find out the purpose of processing their data and whether they are used in compliance with the purpose,
- to know the third parties to whom their personal data are transferred in country or abroad,

- to request correction of personal data if they are incomplete or inaccurately processed,
- to request deletion or destruction of personal data under the conditions stipulated in Article 7 of PPD 7. to request reporting of the operations carried out in compliance with sub-paragraphs (e) and (f) to third parties to whom his personal data have been transferred,
- to object to the occurrence of a result against the person himself/herself by analyzing the processed data exclusively through automated systems,
- to claim the damage arising from the illegal processing of their personal data.
